

# **WWEST Associate Chair Application Information**

Thank you for your interest in becoming a Westcoast Women in Engineering, Science and Technology (WWEST) Associate Chair. This is a competitive application process with a closing deadline of **September 30**, **2024**. Funds will be dispersed to successful candidates and their programs, in Fall 2024 (November), and a final report due August 31, 2025.

A maximum of 3 Associate Chairs will be awarded and will be notified of successful submissions, via email.

## **Eligibility Criteria:**

- Applicants must be a tenure track faculty member in a research stream (Tri-Council or equivalent funding recommended). Preference given to those in a NSERC field at a recognized Postsecondary Institution in British Columbia or the Yukon, and committed to equity, diversity and inclusion (EDI) and closing the gap on underrepresentation in Science, Technology, Engineering and Mathematics (STEM).
- Associate Chairs will receive \$10,000 to be used toward programming that increases the interest and visibility of women and underrepresented people in STEM.
- These funds must be matched by Donor or Faculty and Institution of which the applicant works. Grant funds are ineligible as matching funds. In-kind and cash contributions, or a combination thereof, are acceptable forms of matching funds.
- Up to 50% of program funds may be used for salary. Note: Funds are NOT to be used for the Associate Chair salary.
- Budget and spending must comply with NSERC and Tri-Council policies (ie. No alcohol or gifts).
- Funds will be transferred from the University of British Columbia via invoicing initiated by the Associate Chair's institution.

### **Benefits of this Support:**

- Elevate awareness of individual programs and increase their output in equity, diversity and inclusion initiatives which are recognized by, and support, the institution or region.
- The intent is to build or advance a unique program supporting goals of WWEST and CWSE and to build relationships and a historical record for NSERC with the potential ability to join CWSE BC/Yukon Region in future Program Requirements.

#### WWEST's Role:

- Support lessons and training IF the Associate Chair program is interested.
- Share research where requested.

## **Requirements:**

- Formal adjudication is based on NSERC's historical application for CWSE (see Rubric).
- Year-end reporting and metrics summary to be submitted by August 31, 2025.
- Upon successful adjudication, a formal contract signed by the Department Head and Associate Chair.
